**Regional Tournament:** Patti Stuhlman report: 155 rooms have been reserved (120 were committed). 550 tables are expected (1/2 of tables played in 2019). Jane will send out the final email today. Volunteers are needed: Caddies-one per day, \$35 per session (9:30 to 6:00), Greeters, Standby Partners (will play for free). Players must register vaccinations and receive a wrist band.
